<b>RECOMMENDED ACTION:</b> That the Board of County Commissioners approves a proposal award to Griffith Centers for Children for Comprehensive Parenting Time Services.

### **BACKGROUND:**

Adams County Human Services Department Children and Family Services Division provide parenting visitation time to abused and neglected children in foster care or in relative placement. The environment for parenting visitation time between children and their parents must be in a safe, calm, and neutral location. The highest priority is keeping children safe. Any problems that may occur when children are placed out of the home, can be managed in a more comprehensive parenting visitation environment. When parenting time is available to parents on a more frequent basis, the resolution of the child's situation will occur more quickly. The comprehensive parenting time services will provide for a continuum of parenting time opportunities.

A Request for Proposal (RFP) was performed for the services of qualified agencies for Comprehensive Parenting Time Services. The solicitation was posted on the Rocky Mountain E-Purchasing System in March 2016.

Three options were proposed for submission:

Option A: Supervised Parenting at Adams County Human Service Department and Supervised Community Parenting Time

Option B: Supervised Community and Home-Based Parenting Time

Option C: Therapeutic parenting Time

Six proposals were submitted: The Griffith Center for Children, Colorado Boys Ranch YouthConnect, Alice Riley, Lifelong, Inc., Shiloh House, and Maple Star Colorado. All were evaluated on the following criteria:

**Evaluation Factors:**

1. Project team and past project experience.
2. Offeror's fee structure for performing the work.
3. Project approach, ability to meet timeline and provide requested deliverables

The funding will be from the CORE Services allocation grant. After a thorough evaluation, the evaluation committee is awarding five (5) agreements in the amounts listed below:

Griffith Center for Children	Part's A and C	\$138,000.00
Colorado Boys Ranch YouthConnect	Part's B and C	\$ 78,000.00
Maple Star	Part B	\$ 44,000.00
Lifelong, Inc	Part's B and C	\$ 20,000.00
Shiloh House	Part B	\$162,500.00

All awardees fees are considered fair and reasonable for the scope of services. Purchasing is in agreement with the recommended awards totaling \$442,500.00 for the first year of services.
