<b>RECOMMENDED ACTION:</b> That the Board of County Commissioners approves and signs the agreement with AIMS Community College for FY2017.

#### **BACKGROUND:**

Adams County Sheriff's Office certified, P.O.S.T. (Peace Officer Standards and Training) approved instructors provide skills training, CPR and Tacitical Casulity Care for Aims Community College P.O.S.T. academy students. Each new Aims academy session requires a new signed agreement between the parties. This session will run from January 14, 2017 to April 15, 2017 and will cover 30 Aims students.

There is no net cost to Adams County for providing services related to this agreement. Aims Community College compensates Adams County for the use of FLATROCK Training Center, training vehicles and hourly/overtime costs for the Adams County Sheriff's Office personnel who provide the instruction.
