<b>RECOMMENDED ACTION:</b> That the Board of County Commissioners Approves a bid award to H2 Enterprises and JK Transports Inc. to provide Truck Hauling Services.				

# **BACKGROUND**:

The Transportation Department, Operations Division (Transportation) employs 25 tandem trucks which haul roughly 14 tons per truck. These trucks are utilized for various types of work including but not limited to: asphalt repair, excavating, and ditching, street sweeping and litter control. Due to hauling capacity, these trucks are more efficient and better utilized in short hauls within their assigned area and not for long haul distances.

Due to weather and workload backlogs, Transportation recognizes the need to contract longdistance truck hauling services to catch up on gravel maintenance, pavement maintenance, Right of Way maintenance, and drainage maintenance in eastern Adams County. Transportation reviewed and evaluated their maintenance operations and found by utilizing contract truck hauling they will experience an increase in production and realize significant time saving allowing other vital work functions to be completed.

A formal Invitation for Bid was posted on Rocky Mountain E-Purchasing. Bids were opened on June 10, 2016. Six companies submitted bids. All rates listed are hourly.

Transportation reviewed all bid responses for truck hauling services and recommends awarding purchase orders to the following two vendors:

- **H2 Enterprises** Vendor offers 5 side dump trucks and 5 belly dump trucks. These types of trucks are best suited for hauling gravel road fill, to raise low sections of the roads (high grade). The recommendation is to award 1,120 hours of the proposed 2,800 hours defined in the RFP. The hourly rate is \$89.25 per hour, resulting in a total award of **\$99,960.00.** H2 Enterprises submitted the lowest hourly rate.
- JK Transports Inc Vendor offers end dump trailer trucks. These trucks transport 28 tons per load and are best suited for hauling gravel road to the paver for gravel surfacing. The capacity allows the Operations Division to complete gravel surfacing in half the time, freeing up county trucks and staff to complete other functions and provide short haul of materials. The recommendation is to award 1,680 hours of the proposed 2,800 hours defined in the RFP. The hourly rate is \$90.00, resulting in a total award of \$151,200.00. JK Transports Inc. (JK) hourly pricing was equal to all other vendors who offer end dump trucks. JK has a larger fleet of trucks and currently provides Adams County Regional Park and Arapahoe County with similar services. Therefore, it is believed that JK Transport provides the best value to Adams County.
