**RECOMMENDED ACTION:** That the Board of County Commissioners Approves the Agreement Regarding a Flood Hazard Area Delineation for the South Platte River

## **BACKGROUND**:

This Agreement is with the Urban Drainage and Flood Control District (District) regarding a flood hazard area delineation of the South Platte River within Adams County (County).

The County, the District and other local governments (the Sponsors) wish to proceed with development of a flood hazard area delineation report for the South Platte River from Chatfield Dam to Baseline Road (Project). This Agreement will commit the County to funding in the amount of \$18,000 to the Project. The District will contribute \$95,000 to the Project.

The South Platte River within the County was previously studied in conjunction with other local governments. The County, the District, City of Brighton, City of Commerce City, City of Thornton, Metro Wastewater Reclamation District, Denver Water and South Adams County Water and Sanitation District participated in a joint drainage study titled, "Flood Hazard Area Delineation, South Platte River, Adams County, Colorado," by CDM, dated April 2005. The Sponsors wish to update this outdated study.
