RECOMMENDED ACTION: That the Board of County Commissioners Approves a bid award to American West Construction, LLC., for the Kenwood-Dahlia Outfall Project Phase Three Storm Sewer and Roadway Improvements.

BACKGROUND:

The purpose of the Kenwood-Dahlia Outfall Project is to install 1,700 feet of 84-inch storm pipe and associated storm drainage inlets and manholes. As a result, these improvements will fully connect the drainage system to the South Platte River for the southern half of the Dupont neighborhood in Commerce City and unincorporated Adams County. The uphill and downhill drainage systems were constructed in Phase One and Two of the Project. Phase Three, the last segment of the Project, will complete the section that will provide a functional storm sewer outfall to collect runoff and convey these flows to the South Platte River. Completion of this outfall will reduce water backup and the creation of ponds in the area.

A formal Invitation for Bid was posted on Rocky Mountain E-Purchasing System and advertised in the Daily Journal. Bids were opened on June 29, 2016. Seven companies submitted bids. After verifying the unit prices for each company, the Transportation Department confirmed that American West Construction, LLC., is the lowest, responsive, and responsible bidder and recommends awarding the project to American West Construction, LLC., in the amount of \$2,873,593.00. Adams County will receive \$2,530,645.00 of Community Block Grant Disaster Relief funds for the construction of the Project, from the Department of Public Safety, Division of Homeland Security and Emergency Management.
