RECOMMENDED ACTION: That the Board of County Commissioners approves the modification request from Adams County for the Clear Creek Trailhead Reconstruction project.

BACKGROUND:

On November 6, 2014, Adams County was awarded \$200,000 in Open Space Sales Tax funds for the Clear Creek Trailhead Reconstruction project. The project included improvements to drainage and redesign of the parking lot, installation of an entrance sign, and improved lighting for security.

The Clear Creek Trail has many access points and improvements were planned to one, Lafayette Park. After consulting the county's Transportation and Community and Economic Development departments, it was determined that the original plan to renovate the Lafayette Park Trailhead would cost much more than anticipated. Representatives from Adams County, the Clear Creek Watershed Foundation and the Colorado Department of Transportation mutually agreed to focus on restoring the property to an upland riparian condition and removing that trail access point.

To ensure adequate trail access for the Welby neighborhood, Adams County plans to make improvements to the Engineers Lake Trailhead, which is located less than one mile east of the Lafayette Park Trailhead. Improvements to the Engineers Lake Trailhead will include a new parking surface with landscaping, stormwater detention, signage and solar lighting.

Adams County would like approval to modify the project to include the restoration at Lafayette Park and the improvements to the Engineers Lake Trailhead with the awarded \$200,000. The Open Space Advisory Board voted unanimously in support of the modification on July 27, 2016. Staff recommends approval of the site modification in order to improve both trailhead locations along Clear Creek.
