SUBJECT: Resolution approving a temporary construction easement from Adams County to Brighton School District 27J for construction of roadway and storm water drainage facilities (**Temporary Construction Easement**)

RECOMMENDED ACTION: That the Board of County Commissioners approves the construction and maintenance agreement for storm water drainage facilities and roadway improvements

BACKGROUND:

Brighton School District 27J ("District") plans to construct a new high school near the intersection of Yosemite and East 136th Avenue. As a requirement for construction of the new high school, the District is required to construct a new roadway intersection and storm water drainage facilities to serve the development. The drainage facilities and roadway will serve the school and surrounding future development within the City of Thornton. In fulfilling the requirement for the offsite improvements, the District is requesting a temporary construction easement from Adams County for the construction of the storm water drainage facilities and roadway improvements. These improvements will be located at the intersection of Riverdale Road and Yosemite Street and within the Adams County Regional Park and Golf Course property. The attached Temporary Construction Easement has been negotiated for the granting of the easement under mutually agreed upon conditions to protect the County's property.
