## **BACKGROUND**:

The Neighborhood Services Division of the Community and Economic Development Department is responsible for ensuring Adams County Residents are compliant with Blight Abatement Codes. These codes are in place to promote health and safety, and to protect the community from blight and deterioration. Upon inspection of a blight violation, the Neighborhood Services Division will send a notice of violation to the property owner. If the property owner is not in compliance, then Neighborhood Services will contact the contracted vendor to come out to the property to mow weeds, remove brush, litter and debris, repair fences and bring the property back into compliance.

In May of 2016, an agreement was awarded to Ground Services Company to provide Blight Violation Services for Adams County. The Community and Economic Development Department finds the services provided by Grounds Services Company satisfactory.

Staff recommends that the first renewal option to extend the agreement for one additional year be approved with Grounds Services Company in the not to exceed amount of \$65,000.00, which is within budget, and brings the total contract value to \$140,000.00. The previous year's contract was \$75,000. The 2017 amount is lower due to less anticipated need.
