RECOMMENDED ACTION: That the Board of County Commissioners Approves the IGA with the County of Boulder for local match contribution towards the State Highway 7 BRT Station Design Study

BACKGROUND:

In July 2015, the Board provided a commitment in principle up to \$25k towards a Broomfield-sponsored DRCOG grant to conduct a Study to refine the BRT stations along S.H. 7. See attached letter of commitment. Broomfield did not initially receive the grant, but in mid-2016 grant funds were returned to DRCOG which were then offered to the City for the SH 7BRT Study.

Staff informed the Board of the renewed grant opportunity on August 9, 2016, at which time the Commissioners reconfirmed their support towards the study.

Through various discussions with the jurisdictions along the corridor, it was determined Boulder County would manage the study with Thornton, Broomfield and Adams County providing \$17k, \$10k and \$13k respectively towards the grant's local match requirement. Both Broomfield and Thornton have executed IGAs with Boulder their share of local match.

The Board approved the supplemental budget request for the county's \$13k local match on April 25, 2017.
