<b>RECOMMENDED ACTION:</b> That the Board of County Commissioners approves a purchase order to Colorado West Equipment Inc., for Commercial Transport Prison Buses				

## **BACKGROUND**:

On October 5, 2017 Adams County issued a formal Request for Proposal (RFP) on the Rocky Mountain ePurchasing System seeking a qualified contractor to provide two Commercial Transport Prison Buses utilized for inmate transportation by the Sheriff's Office. Proposals were opened on November 1, 2017 with two firms, Transwest and Colorado West Equipment Inc., submitting proposals.

Proposals were evaluted based on the following criteria; proposed Cab/Chassis/Engine combination, design functionality of the buses, contractor ability to meet all vehicle requirements (one bus will meet American with Disabilities Act requirements), contractor experience and vehicle costs. After a thorough evaluation by the project committee, the decision was made to purchase the prison buses from Colorado West Equipment Inc., for the following reasons; functionality of the interior of the buses, engine power and options and vehicle pricing. The proposal received from Colorado West Equipment Inc., was the highest technical scoring response as well as the lowest cost.

It is recommended that the Board of County Commissioners approves a purchase order to Colorado West Equipment Inc., for the purchase of two Commercial Transport Prison Buses in the total amount of \$382,996.00.
