BACKGROUND:

In 1991, Article 5.5 was enacted to create the Colorado Family Preservation Act. The program is defined in State Statutes as Family Preservation, the program is referenced in the Code of Colorado Regulations (12 CCR 2509-4) as Core Services. The Core Services Program was established within the Colorado Department of Human Services in 1994 and is statutorily mandated to provide strength-based resources and support to families when children are at imminent risk of out of home placement and/or are in need of services to maintain a least restrictive setting.

Request for Proposals were previously performed and renewals approved for the Core Service agreements by the Board of County Commissioners. Staff is requesting the renewal of the following agreements for the 2018/2019 year as follows:

Home Based Intervention:

Home based interventions are services provided primarily in the home of the client and can include the following services: therapeutic, concrete, collateral and crisis intervention. These are directed to meet the needs of the child and family.

Family Team Meeting:

Family Team Meeting (FTM) is a family centered meeting that brings the family and the Department together to model teachings and philosophy from Team Decision Making (TDM) and Family Group Decision Making (FGDM). The purpose of the FTM is to increase family engagement and involvement at Adams County by coordinating and scheduling FTMs for every case prior to an anticipated out of home placement, prior to any change in placement and prior to reunification with their family.

Domestic Violence Reduction Program:

The goal of the Domestic Violence Reduction Program is to reduce the impact of domestic violence on children served by child welfare in Adams County. This includes providing proactive support to families with co-occurrence of domestic violence and child maltreatment, engage families in appropriate services, promote increased safety for abused children and adults as well as educate and empower children about domestic violence.
