BACKGROUND:

Request for Proposals were previously performed in August of 2017, for Diligent Search Services. The Board of County Commissioners approved an agreement with Maple Star Colorado to provide Diligent Search Services for the Adams County Human Services Department.

The Diligent Search program consists of Family Finding Specialists who provide caseworker support such as, but not limited to, locating, engaging, connecting, and supporting family resources for children and youth to provide timely and adequate permanency. The Family Finding Specialists will reach out to families and engage them through telephone contact, face-to-face meetings, and family team meetings.

Staff is recommending the approval of the first renewal as follows:
