RECOMMENDED ACTION: That the Board of County Commissioners approves Change Order One to the agreement with RockSol Consulting Group, Inc., for additional engineering design services for the Adams County York Street Phase II – 78th Avenue to 88th Avenue Improvements Project.					

BACKGROUND:

In July of 2018, RockSol Consulting Group, Inc., was awarded an agreement to provide Engineering Design Services for the 2018 York Street Phase II – 78th Avenue to 88th Avenue Improvements Project.

Change Order One is being requested for additional design services that are now required per the new Senate Bill 18-167, which passed August 2018 for utility design capturing standards. The goal of Senate Bill 18-167 (SB 167) is to increase public safety and reduce the utility related costs and delays throughout the project lifecycle, including construction. Pursuant to SB 167, RockSol Consulting Group, Inc., submitted their proposal to implement ASCE 38 Quality Level B (QL B) utility designation for this project.

The change order information was presented to the Board of County Commissioners at the November 13, 2018 Study Session.
