#### **BACKGROUND:**

TruStile Doors LLC is a Colorado-based company that has had its home within Adams County since 1999. Recently, Trustile Doors was in need of establishing a new 268,000 square feet location that would be able to serve the capacity needed for the continued growth of their business. Adams County recognized the need to retain TruStile Doors within the county, and has negotiated an Incentive Agreement with TruStile Doors for the retention and expansion of their business within Adams County. The new TruStile facility is located near 71<sup>st</sup> street and Washington Street in Adams County and is on track to open in 2020.

TruStile Doors plans to employ and retain two hundred sixty-five (265) employees at the facility once it opens and plans to add an additional sixty (60) employees at the facility by the end of calendar year 2026. TruStile agrees to have the following minimum number of employees at the facility during the term of this agreement: 285 by the end of 2021; 295 by the end of 2022; 305 by the end of 2023; 315 by the end of 2024; 325 by the end of 2025; and 325 by the end of 2026. Incentive payments in the form of tax rebates are conditioned upon the compliance of Trustile Doors in meeting these thresholds.
