**RECOMMENDED ACTION:** That the Board of County Commissioners approves an agreement with Pueblo Hotel Supply dba Grady's for the Kitchen Equipment Replacement Project at the Adams County Detention Center.

#### **BACKGROUND**:

The Detention Center was built in 1984 and maintains the original kitchen equipment, which is now outdated and continues to break down, creating substantial repair costs annually. With the assistance of a consultant, it was determined that there is a need for the replacement of several pieces of equipment in the main kitchen and staff dining area. In 2019, a Capital Improvement Plan project was approved for \$675,000; \$440,000 for the kitchen equipment scope of work and \$235,000 for the construction remodel scope of work.

A formal Invitation for Bid (IFB) was posted to Bidnet and responses were opened on January 16, 2020. Four bids were received. One bid was deemed non-responsive. Listed below are the responsive bids:

Pueblo Hotel Supply dba Grady's was the lowest responsive and responsible bidder. The Sheriff's Office and Facilities Operations and Fleet Management Department recommends that Pueblo Hotel Supply dba Grady's be approved to provide the Kitchen Equipment Replacement at the Adams County Detention Center in the not to exceed amount of \$386,014.00.
