RECOMMENDED ACTION: That the Board of County Commissioners approves an Agreement with Meyers & Sons Construction, LLC, for the Rehabilitation of 96 th Avenue Bridge over Bijou Creek Phase Two project.

BACKGROUND:

The Adams County Public Works Department determined the need for construction services to rehabilitate the structural condition of the existing 96th Avenue bridge over Bijou Creek in eastern Adams County. A Phase One project to rehabilitate the bridge substructure and approach roadway was completed in 2020. The Phase Two project will rehabilitate the superstructure and complete the overall bridge work. This project continues the County's efforts for improvements to the bridge inventory.

A formal IFB was posted on BidNet. Bids were received on January 28, 2021, from the following responsive companies:

After review, it was determined that Meyers & Sons Construction, LLC, was the lowest, responsive and responsible bidder. The recommendation is to award an Agreement to Meyers & Sons Construction, LLC, for the Rehabilitation of 96th Avenue Bridge over Bijou Creek Phase 2 project for a total not to exceed amount of \$546,731.75.
