<b>RECOMMENDED ACTION:</b> Board of County Commissioners approve and authorize the Chair to sign Subrecipient Agreement between Adams County and Maiker Housing Partners to award Emergency Rental Assistance funds.

### **BACKGROUND:**

On May 10, 2021, Adams County was granted \$11,176,138 in Emergency Rental Assistance funds by U.S. Treasury through Section 3201(a) of the American Rescue Plan Act of 2021, Pub. L. No. 117-2 (March 11, 2021), further referred to as ERA2. ERA2 is assistance available for low-income people who have been negatively impacted by the COVID-19 and need assistance with paying their rent and utilities.

On June 15, 2021, the Board of County Commissioners agreed to allocate ERA2 funds to local housing authorities that serve Adams County residents and to the non-profit agency, The Community Firm (d/b/a COVID Eviction Defense Project), to provide rent and utility assistance, and housing stability services.

The attached Subrecipient Agreements allocate ERA2 funds per the Board's recommendation on June 15, 2021 to Maiker Housing Partners. The attached Resolution authorizes the Chair to execute the Agreement.
